NEVADA DEFENSE WITHIN LIMITS – COMPANY ACTION REQUIRED

Nevada enacted Chapter 191 of the laws of 2023 (AB-398), which generally prohibits insurers from issuing or renewing a policy of liability insurance that contains provisions that reduce or limit the availability of liability coverage stated in the policy by the costs of defense, legal costs and fees and other expenses for claims. This change is effective for new and renewal policies issued on or after 10/1/2023 for policies written in the admitted market. 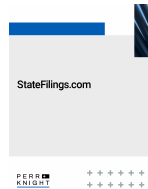
