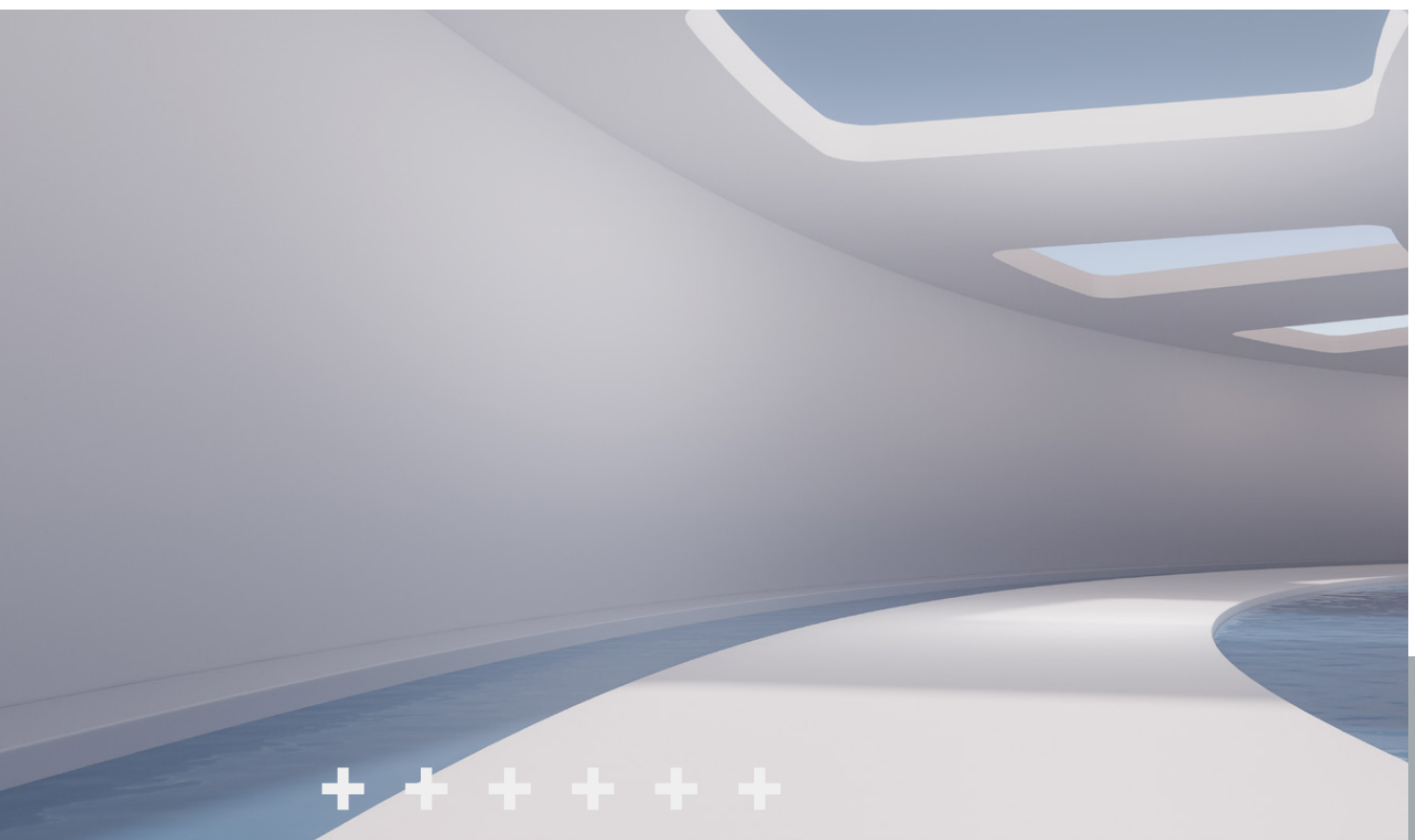

## **EFFICIENT PROCESS**

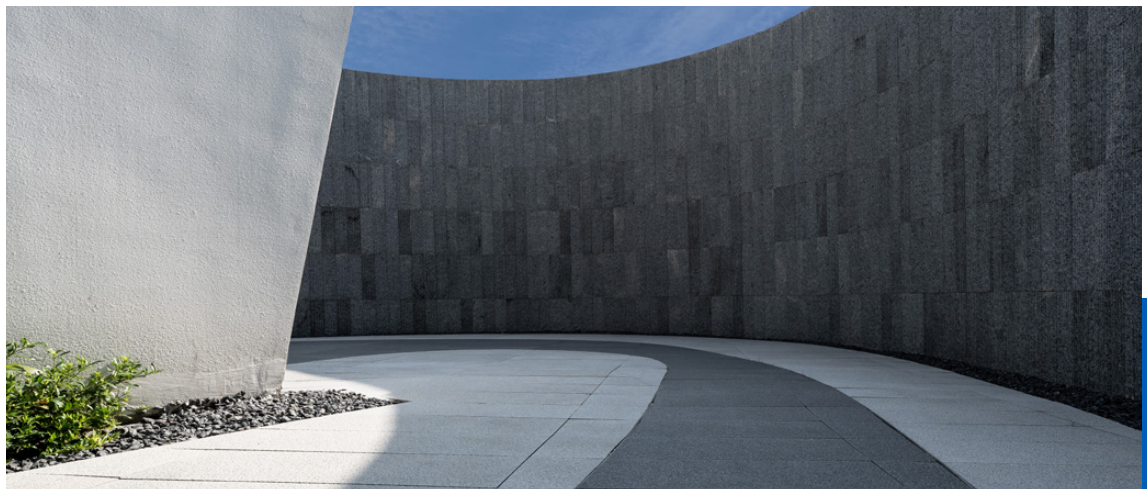
